



RADIO LICENSE EXTENSION AGREEMENT FOR GROUP ACCOUNTS

WHEREAS, **BMI**[®] and the Radio Music License Committee (the “RMLC”) have been negotiating the terms and conditions of a license agreement for the period commencing January 1, 2010 (the “2010 Agreement”).

WHEREAS, _____ (“Group Owner”) has advised BMI that, for reasons of administrative convenience, it desires by the execution of this single document (hereinafter “Group Extension Agreement”) to bind each of the radio stations in its station group, as well as those for which Group Owner is a Local Manager as defined in Section 2.G. of the BMI Radio Station Blanket/Per Program License Extension Agreement (the “2007 Agreement”) to this Group Extension Agreement instead of causing each of said stations to execute separate extension agreements.

NOW THEREFORE, it is hereby agreed, by and between BMI as party of the first part and Group Owner and each of the entities listed on Schedule A and Schedule B as parties of the second part, as follows:

1. Group Owner warrants and represents that the individual signing this Group Extension Agreement on Group Owner’s behalf and on behalf of the entities listed on Schedule A and Schedule B has the express, actual authority to bind contractually Group Owner and all of the entities listed on Schedule A and Schedule B, and that each of the entities listed on Schedule A and Schedule B intends to be bound by this Group Extension Agreement for Group Accounts, and that each of said entities has authorized and instructed Group Owner to execute this Group Extension Agreement on its respective behalf.

2. It is agreed by all the parties that each of the entities listed on Schedule A and Schedule B intends to be bound by (a) the 2010 Agreement, including all terms and conditions thereof; or (b) the decision of the BMI Rate Court in a proceeding between BMI and the RMLC, in the event an agreement is not reached.

3. In the event that BMI and the RMLC are unable to finalize the terms of the 2010 Agreement by December 31, 2009, Group Owner and each of the stations listed on Schedule A and Schedule B agrees to be bound by an interim license which shall commence on January 1, 2010 and which shall embody each and every term and condition set forth in Station’s 2007 Agreement except for the Term and license fees (“Interim License Agreement”). Each station’s interim monthly license fee shall be the sum equal to 4% less than the station’s December 2009 license fee, and may be adjusted based upon agreement on a different interim fee agreed to between BMI and the RMLC, or as determined by the BMI Rate Court. The interim and/or final license fees agreed to by BMI and the RMLC, or as determined by the BMI Rate Court, shall be applied retroactively to January 1, 2010, and Group Owner and each of the entities listed on Schedule A and Schedule B shall be obligated to pay BMI any monies owed BMI as a result of such retroactive adjustment of fees, and BMI shall be obligated to credit the account of Group Owner and each of the entities listed on Schedule A and Schedule B any monies owed as a result of such retroactive adjustment of fees. The Interim License Agreement shall continue until a final 2010 Agreement is reached as a result of the ongoing negotiations between BMI and the RMLC or a decision is rendered by the BMI Rate Court in a proceeding between BMI and the RMLC.



4. Group Owner and each of the entities listed on Schedule A and Schedule B hereby waive the right to make an Application for fees to BMI, or to make an Application to the BMI Rate Court for the period commencing January 1, 2010.
