

PEERMUSIC LATIN SCHOLARSHIP COMPETITION

2012 OFFICIAL RULES

1. Applicants must be a student enrolled at a college or university located in the United States or Puerto Rico.
2. The submitted work must be an original song or an instrumental work in a Latin genre. Both lyrics and music must be original and not based on any prior work. Applicants may submit only one song to the competition.
3. Applicants must have reached their 16th birthday as of February 10, 2012 and be less than 25 years of age as of that date. In the case of a joint or co-written song or composition, all applicants must meet all qualification requirements and each co-writer must submit a completed application. Former winners (other than Honorable Mention) of this competition are not eligible.
4. Applicants must not have had any musical work commercially recorded or distributed. The applicant must warrant that he or she has not assigned any rights in the submitted work to a publisher, record company, licensing organization or any other person or entity.
5. The entry must be submitted on CD or MP3, which should be labeled only with the title of the song. It must be accompanied by one typed copy of the lyric. None of these items may indicate the name of the applicant or their school. The CD or MP3, one typed lyric sheet, and the fully completed application (or applications when there are co-writers) must be included in one submission. A faculty member at the applicant's school must confirm the application. Applicants should retain copies of their recordings and lyrics since the Foundation will not undertake to return materials.
6. If the winning work is written by two or more qualifying applicants (e.g., a composer and lyricist), the scholarship award will be divided equally between them.
7. Applications should be submitted no later than February 10, 2012. If using paper application, the submission should be sent to:

8. One \$5,000 award will be available for the competition. The Foundation reserves the right to make no award or to award a prize or prizes totaling less than the full amount.
9. The BMI Foundation shall have the right (but shall have no obligation) to license up to three public performances of a winning composition and, in the case of works of a popular nature, authorize appropriate musical arrangements to be made for such performances. The BMI Foundation shall also have the right to post a recording of any winning composition on the bmi.com and the bmifoundation.org websites and to authorize the reproduction and distribution on audio tape and/or CD of no more than twelve (12) copies of each winning work. All other rights under the copyright law remain vested in the composer and lyricist.
