



Low-Power Television Group License Agreement

WHEREAS, _____ (“**Group Owner**”) has advised BMI that, for reasons of administrative convenience, it desires by the execution of this single document to bind each of the low-power television broadcasting stations in its station group (i.e., those entities that are listed on Schedule A) instead of causing each of said stations to execute separate agreements.

NOW THEREFORE, it is hereby agreed, by and between BMI as party of the first part and Group Owner and each of the entities listed on Schedule A as parties of the second part, as follows:

1. Group Owner warrants and represents that the individual signing this Agreement on Group Owner’s behalf and on behalf of the entities listed on Schedule A has the express, actual authority to bind contractually Group Owner and all of the entities listed on Schedule A and that each of the entities listed on Schedule A intends to be bound by the BMI Low-Power Television Blanket License (the “**Individual License Agreement**”), and that each of said entities has authorized and instructed Group Owner to execute the indicated license by this instrument on its respective behalf.

2. It is agreed by all the parties that each of the entities listed on Schedule A is bound by the Individual License Agreement, including all terms and conditions thereof, as if each individual station had executed a separate Individual License Agreement.

3. This Agreement shall be deemed part of and incorporated into the respective license agreements of each of the entities listed on Schedule A hereto
